These Terms and Conditions ("**Terms**") govern the use of SMS messaging services provided by the Agua Caliente Band of Cahuilla Indians Tribal Court ("**Tribal Court**," "**we**," "**us**," or "**our**"). By opting into our SMS program, you agree to receive SMS messages from the Tribal Court, in accordance with these Terms and The Campaign Registry ("**TCR**") compliance standards.

Consent and Opt-In Requirements

- By opting in, you provide express consent to receive SMS messages from us regarding your account services.
- Opting into the SMS program is voluntary and separate from any other service we provide.

 - **Opt-In Message:** Thank you for opting into the Tribal Court texting. Message frequency varies. Message & data rates may apply. Reply **STOP** to unsubscribe. Text **HELP** or call **(760)866-6500**

Message Frequency and Types

- Message Frequency varies.
- Message Types: Messages may include service alerts and account notifications.
- Message and data rates may apply according to your mobile carrier's standard rates.

Opt-Out Instructions

- You may opt out of the SMS program at any time by texting **STOP** to **(760) 287-0919**.
- Once you send the **STOP** request, you will receive one final confirmation message confirming that you have been unsubscribed. No further messages will be sent unless you opt back in.

- By opting in, you agree to the Tribal Court's Privacy Policy and acknowledge our commitment to protecting your data.

- The Tribal Court and cellular carriers are not responsible for any delayed or undelivered messages caused by factors outside our control, such as mobile carrier delays or network outages.
- The Tribal Court and cellular carriers are not liable for any direct, indirect, incidental, or consequential damages that result from the use of, or inability to use, the SMS program.
